TREATMENT IS DELIVERED VIA TWO CORE PROGRAMS: THE RESIDENTIAL AND THE OUTPATIENT SUBSTANCE ABUSE TREATMENT PROGRAMS WITH A FULL CONTINUUM OF SERVICES AT THREE LOCATIONS. THE INTENSIVE RESIDENTIAL PROGRAM REQUIRES A MINIMUM OF 20 HOURS PER WEEK OF TREATMENT SERVICES FOR APPROXIMATELY 30 DAYS. CLIENTS LIVE ON SITE WHILE BEING CLOSELY SUPERVISED. CLIENTS DO NOT LIVE ON SITE. THIS PROGRAM OFFERS FLEXIBILITY OF WORKING WITH CLIENT SCHEDULES. CLIENTS AVERAGE FIVE HOURS OF TREATMENT PER WEEK. 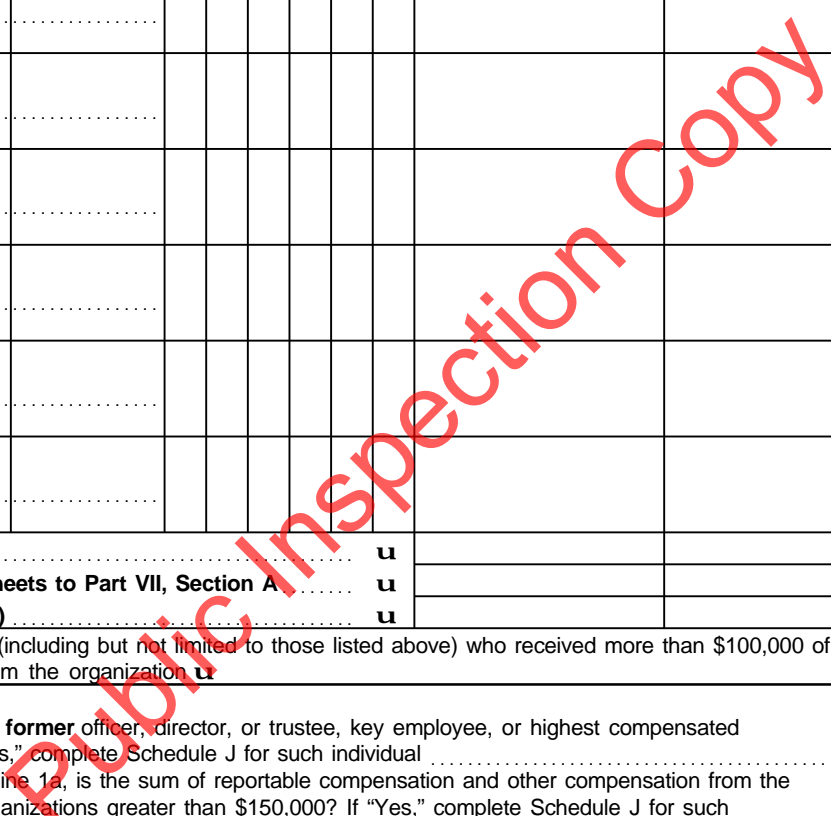

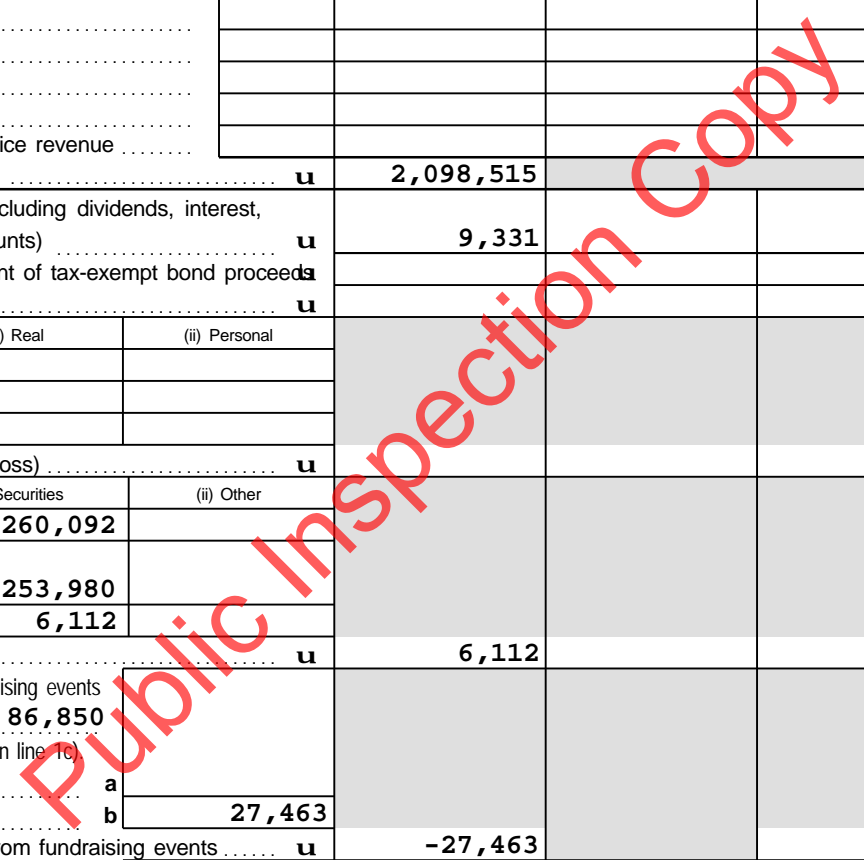
